# **Pickleball Update**

Steve Friedland led a discussion of where the committee is and the ongoing process. Scheduled days will remain the same as last season with each club having 3 days.

The community will vote mid-June through August on the proposal to build stand-alone courts on the grassy knoll in front of the clubhouse. Both clubs will need to work together to garner support for this referendum. A request for Board members to attempt to enlist non-tennis club members to solicit neighbors in support of the project was made. Most Board members voiced their intent to participate. No objections were made to the request.

**Treasurer's Report** Monica reported a starting balance of \$3360.80. Initial membership deposits reflect a current balance of \$4500.80

**Membership Report 2023** To date there are 38 registered club members: 24 women and 14 men. We anticipate that we should have about 100 members as people return from Florida. It was noted that the club is not open to non-residents, other than those very few former residents who were "grandfathered" in. Guests may be invited to play by members during non-club hours provided they sign the guest book and waiver at the concierge desk.

Prior to Committee Reports, Steve impressed upon the Executive Board that this Board represents the interests of Westlake Tennis Club and no other Club. Also reaffirmed was that Ted Pelekanos is our WebMaster with Mary McCann as his back up.

#### STEVE FRIEDLAND:

## **Pickleball Ad Hoc Report:**

Denis Glaude, Pickleball's representative on the Ad Hoc Committee, has resigned. The Ad Hoc need a representative from Pickleball. At the next BOT meeting the Board will be unveiling their plan, which has been approved, to proceed with the 'grassy knoll' area for pickleball. Approximately a year ago, Gary Schumacher, recommended by FWH, surveyed both the grassy knoll and the complete refurbishment of the tennis courts. At that time, he estimated approximately \$96,000 to complete the grassy knoll project and \$175,000 - \$250,000 for each double tennis court. That estimate has probably increased significantly during the past year. With the community's reserves at its lowest level in many years, the conversion, if the vote for the grassy knoll project fails, would not be stated until 2025 or 2026. The grassy knoll project could begin in early 2024, if approved.

**Opening Presentation:** a draft of the Opening Presentation was reviewed. The Round Robin listed for 9/16 will be changed to 9/9.

**Autism:** Steve met with Tony and they have agreed on a price of \$30 PP for the 2023 July 29 Event. Main dishes will include, fish, chicken and pasta w/vegetables; cookies, soda and water are also included.

#### **MONICA STRAUSS:**

Finance—Our current check book balance is \$5,550.80. We started with a balance of \$3,360.80.

Membership----We currently have 73 members, 26 men and 47 women which includes 3 new members.

**TED PELEKANOS**, will be the Men's Master Schedulers (Bob Curia is the backup). He has already prepared a list of the men's schedulers as well as the court schedules for next season. Going forward, Bob Curia will be the point man for the men's rating matches and will arrange all the men's inter-community

matches. Careful attention must be paid as to when these matches are scheduled due to the sharing of the courts with pickleball.

Ted will be Mary McCann's backup for posting the women's weekly schedules. Mary will also be the backup for posting the men's weekly schedules.

Ted will also be tweeking the tennis website.

## **MARCIA WEINBERG:**

Has contacted Claude DeRogatis concerning future structured clinics. He affirmed that he will be available.

Ranking Committee: the new Ranking Committee, consisting of Marcia, Mike Kaplan, Lauren, Elliot Yezer and Mary McCann, will be getting together shortly to discuss a solution to a) the issue of dwindling members in the B group and b) discuss the possibility to reassigning the players in the existing groups and condensing the groups.

#### STEVE FRIEDLAND: PICKLEBALL AD-HOC COMMITTEE UPDATE

A new member has been added to the Ad-Hoc Committee, Lennie Antonelli.

#### LAUREN FILIPEK: RANKING COMMITTEE REPORT

Since the last Executive Tennis Board Meeting, the Ranking Committee has met twice. The consensus of the Committee is as follows: in order to provide for more competitive games and have larger pools of players to draw from, the Committee is recommending the following:

Women:

A/O and A/1 levels will be combined (creating 18 players): this group will be called 1

A/2 and A/3 levels will be combined (creating 18 players): this group will be called 2

B1, 2 and 3 levels will be combined (creating 12 players): this group will be called 3

Men:

A/0: 7 players: this group will now be called 1

A/1: 11 players: this group will now be called 2

A2 and B1, 2 and 3 levels will be combined (creating 12 players): this group will now be called 3

(30 active players and 3 social)

A letter will be sent to the membership calling for a special meeting to be held Monday, June 5<sup>th</sup> in the Ballroom at 6 P.M. for a vote on this proposed change to the By-laws. If approved, the change will go into effect with the next schedule.

#### STEVE FRIEDLAND:
