A current copy of my insurance policy or proof of insurance stating that the golf cart is covered under the policy with a minimum limit of \$300,000.00 must be submitted to and held in the Community Association office. This policy should name the Westlake Master Association and the Management Company (Premier Management Associates) as certificate holders.
- 4. There will be no lending or sharing of golf carts. Use is restricted to owners of the cart only.

I/We own an electric golf cart and have attached appropriate proof of insurance, showing that this vehicle is insured for use on the streets of the community and the golf course.
